Reclassification of this position is requested in order to establish a more efficient pattern of supervision in the Personnel Office. As the Director becomes more involved in personnel concerns campus-wide and in the development of new programs and services, there is a need for an Assistant Director to assume responsibility for the day-to-day operation of the Personnel Office. The increase in salary reflects the assumption of this new responsibility. It should be noted that this reclassification is being done as part of the system-wide conversion of Personnel Officers to Assistant Directors of Personnel on all four campuses.
