JUNE 17, 1988

WHEREAS, Trustees' Resolution #88-69 approved the restructuring of the School of Social Work at Southern Connecticut State University and renamed it the School of Social Work and Human Services, and

WHEREAS, Trustees' Resolution #88-69 also established that this restructured School be headed by a Dean of the School of Social Work and Human Services, and

WHEREAS, This reorganization would represent a significant increase in overall responsibility for Dr. Frank Baskind, currently Dean of the School of Social Work at Southern Connecticut State University, be it

RESOLVED, That Dr. Frank Baskind be reassigned as Dean of the School of Social Work and Human Services at Southern Connecticut State University at a bi-weekly salary of \$2,318.01 (annual salary of \$60,500), effective June 1, 1988.

Dear Dave:

As a result of the reorganization of the School of Social Work, Dean Frank Baskind will now be responsible for the direct supervision of the following departments in addition to the Department of Social Work as of June 1, 1988.

- Department of Marriage and Family Therapy
- 2. Department of Public Health
- 3. Department of Recreation and Leisure
- 4. Program in Urban Studies

The new School of Social Work and Human Services will consist of approximately 40 FTE faculty. The School will have a Course FTE Enrollment of approximately 750 per semester.

The reorganization represents a significant increase in overall responsibility for Dean Baskind. I am, therefore, recommending that Dean Baskind's salary be increased from \$57,404.00 to \$60,500.00 effective June 1, 1988. This adjustment will be included on our next CSU-1. In addition, Dean Baskind should receive the annual increment in September based upon this new salary.

WHEREAS, Health and Human Services disciplines have been recognized in the campus Role Statement as an area of emphasis at Southern Connecticut State University, and

WHEREAS, Faculty and administration at Southern Connecticut State University have reviewed the current organization of health and human service departments and have concluded that a more effective organization would result if the Departments of Social Work, Public Health, Recreation and Leisure Studies, Marriage and Family Therapy, and the program in Urban Studies could be included in a restructured school entitled the School of Social Work and Human Services, therefore, be it

RESOLVED, That the School of Social Work at Southern Connecticut State
University shall be renamed the School of Social Work and Human
Services and shall include such departments and programs as shall
be designated by the President of Southern Connecticut State
University and shall be headed by a Dean of the School of Social
Work and Human Services, and be it

RESOLVED, That the Role Statement of Southern Connecticut State University, approved by Trustees' Resolution 87-170, is amended to delete the School of Social Work and to add the School of Social Work and Human Services, and be it

RESOLVED, That the changes in School name at Southern Connecticut State
University and the amendment in the Role Statement as provided in
this resolution shall be contingent upon approval of the Role
Statement amendment by the Board of Governors of Higher Education
of Connecticut.
