


Dear Jane:

Dear President Beal:

Enclosed please find a copy of the publication announcing the Tenth Annual National Conference on Law and Higher Education. Bob Garvey provided me with the publication. He feels that the conference offers a very worthwhile opportunity and suggested that I contact you regarding it. As you can see, a number of the topics to be discussed at the conference involve issues which are now pending before our campuses. The conference would therefore provide valuable guidance to me in providing the Connecticut State University with the best advice available in resolving these issues. However, because of recent budget cuts, our office will not fund my attendance at this conference.



Overview of the Conference

For the tenth year, Stetson University College of Law presents a national conference focusing upon current, unresolved legal issues of vital importance to the higher education community. The purpose of the conference is to bring together college and university administrators, attorneys, and representatives of government to discuss current legal and policy concerns shared by members of these constituent groups. This dialogue insures an appreciation of the relationship between law and policy and a comprehensive and pragmatic approach to decision making where legal questions are apparent.

The conference is co-sponsored by the American Council on Education, The National Association of College and University Attorneys, and The National Association of Student Personnel Administrators. The national co-sponsorship of this program, and its audience of administrators and attorneys from throughout the United States, has established the conference as one of the most important legal conferences in higher education. Last year's 435 plus attendees represented more than 185 institutions and law firms from 41 states, Puerto Rico and Canada.

The Conference Program

On its tenth anniversary, the national conference begins with a keynote address on the subject of "The Supreme Court and Individual Rights at the End of the Reagan Era," by Jesse H. Choper, distinguished constitutional law scholar and Dean of the School of Law of the University of California at Berkeley. Following Dean Choper's keynote address, the conference will convene its traditional "Washington Roundtable": a discussion of current Supreme Court cases, and legislative and regulatory issues, involving the Washington representatives of higher education. The balance of the program will focus upon critical legal issues in academic, administrative and student affairs in 1989. Discussion of these issues will be led by a distinguished group of lawyers, administrators, and governmental officials with expertise in those areas of the law, and policy-making, which will directly affect the administration of public and private higher education in 1989. Questions and answers will be a vital part of the conference program.

The Pre-Conference Programs

N.A.C.U.A. Workshop. For the sixth year, the National Association of College and University Attorneys will host a special workshop on Sunday, January 15, immediately preceding the Law & Higher Education Conference. This separate program will focus upon legal issues related to contracts in the college and university setting. The NACUA Workshop is a specially designed program, intermediate in level, for legal counsel and others interested in specific issues relating to contracts. Academic, administrative, and business officers are encouraged to attend. This "pre-conference" program is available to NACUA members and other conference registrants. Registration information for this program and a SEPARATE REGISTRATION FORM are included in this booklet on page 14.

A.S.J.A. Conference. The Association for Student Judicial Affairs (ASJA) will hold its inaugural annual conference immediately preceding the NACUA Workshop and the Law & Higher Education Conference. Sessions for this program are scheduled to begin at 11:00 a.m. Saturday, January 14, concluding at 11:00 a.m. on Sunday, January 15. Conference Director

Professor Robert D. Bickel received his B.A. Degree in Management from the University of South Florida, and his J.D. Degree, with highest honors, from the Florida State University. After a brief period of private practice, he joined the staff of the United States Department of Justice, in Washington. In 1971, Professor Bickel returned to his *alma mater* and was appointed its first full time General Counsel. During his tenure in that position, Professor Bickel represented the University and the Florida Board of Regents in all legal matters affecting the University.

After his seven year tenure as General Counsel, Professor Bickel joined the faculty of the Stetson University College of Law, where he has served as teacher and Assistant Dean of the College. Professor Bickel is the author, co-author or editor of two books and more than 15 published articles and book chapters in the field of Law and Higher Education. His latest book, *The College Administrator and the Courts*, 2d Edition (1988) is now available from College Administration Publications, Inc.

Professor Bickel has lectured at the annual meetings of most national education associations, including NACUA, NEA, NASPA, AAUA, AAAA, NOLPE, SACS, NASULGC, The Corporation for Public Broadcasting, the Federal Bar Association, and many regional or state affiliates of these Associations. Professor Bickel regularly conducts workshops for college administrators and faculty on the subject of law and higher education, and has presented such special workshops in Florida, Georgia, Tennessee, Maryland, Virginia, and Pennsylvania. He is a regular speaker at the annual national conference on law and higher education, sponsored by the Institute for Higher Education, University of Georgia, and at the annual meeting of the Southern Association of Colleges and Schools.

Stetson University College of Law, founded in 1900, is Florida's first law school. Located in St. Petersburg, the College of Law is an integral part of Stetson University and is a charter member of the Association of American Law Schools. 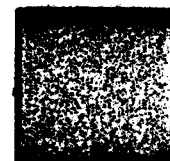
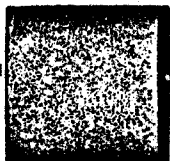
