RESOLUTION

Concerning

THE CONNECTICUT STATE UNIVERSITY GRANT PROGRAM
(Tuition Fund Set Aside Program
for Students with Financial & Employment Needs)



BE IT RESOLVED, That Board Resolution #89-14 dated December 2, 1988 and approved January 13, 1989 is rescinded, and be it further

RESOLVED, That effective for the Spring 1989 semester there shall be set aside each fiscal year from the anticipated Connecticut State University Tuition Fund revenue for that year an amount not less than that required by the Board of Governors' tuition policy, such amount to be used subject to the following conditions:

1. Amounts set aside are to be used for grants to qualified students, for student employment, and may be used to match Federal College Work-Study awards.
2. Grants may be awarded to any undergraduate or graduate student who is enrolled as a full or part-time matriculated student in a degree-granting program, or enrolled in a precollege remedial program, who demonstrates substantial financial need. Substantial financial need shall be demonstrated through the submission of financial information on federally-approved analysis systems forms.
3. A student may be offered institutional employment, if, in the opinion of an aid administrator, the student is in need of such employment to help meet educational expenses.



THE CONNECTICUT STATE UNIVERSITY GRANT PROGRAM

December 2, 1988

- WHEREAS, Section 10a-99(e) of the Connecticut General Statutes requires that the Board of Trustees of the Connecticut State University shall set aside from its anticipated Tuition Fund revenue an amount to be used to provide tuition waivers, tuition remissions, grants for educational expenses, and student employment, and
- WHEREAS, Current Board of Trustees policy on the Connecticut State University Grant Program is in need of revision to permit greater flexibility of administration therefore, be it
- RESOLVED, That Board Resolution #87-62 is rescinded, and be
- RESOLVED, That effective for the Spring 1989 semester there shall be set aside each fiscal year from the anticipated Connecticut State University Tuition Fund revenue for that year an amount not less than that required by the Board of Governors' tuition policy, such amount to be used subject to the following conditions:
1. Amounts set aside are to be used for grants to qualified students, for student employment, and may be used to match Federal College Work-Study awards.
