RESOLVED, That BR #88-111 be rescinded and the following resolution enacted:

RESOLVED, That under the authority granted by Section 10-27, 10a-20, and 10a-89 of the General Statutes, the Board of Trustees for Connecticut State University authorizes an exchange of staff involving Wilfred Boykin, Professor of Mathematics at Central Connecticut State University and Professor Wolfgang Ebenhoh at the University of Oldenburg, Oldenburg, West Germany. The said exchange to be subject to the following conditions:

- A. The salary of Wilfred Boykin shall be paid by Central Connecticut State University;
- B. The salary of Wolfgang Ebenhoh shall be paid by the University of Oldenburg;
- C. Transportation, lodging and other personal expense incurred in the exchange will be fully assumed by the individuals involved;
- D. Wolfgang Ebenhoh will serve in the Mathematics and Computer Science Department at Central Connecticut State University; and
- E. The exchange shall occur during the Fall Semester 1989, which begins on August 22, 1989, and ends December 23, 1989.


