#### RESOLUTION

## concerning

### HIGH SCHOOL - UNIVERSITY COOPERATIVE PROGRAMS

#### AND APPROPRIATE FEES

## April 7, 1989

WHEREAS, It is desirable for the campuses of Connecticut State
University to relate to the high schools of the state and to
provide encouragement to outstanding high school students to
advance or accelerate their educational careers, now,
therefore, be it

RESOLVED, That Trustees Resolution 77-78, Resolution concerning High School-College Cooperative Program at Western Connecticut State College, is hereby repealed, and be it

RESOLVED, That outstanding high school students who are recommended by their guidance counselors or principals and are acceptable to University authorities as being able to undertake university—level courses may be permitted to enroll in courses of Connecticut State University campuses and will be subject to the following rules regarding fees:

- (1) Such students from high schools with which a campus of Connecticut State University has a specific agreement for enrollment in University courses on a space-available basis may be admitted to two University courses per semester and may earn university credit. The president of the Connecticut State University campus may agree to waive all fees for such students or may at her/his discretion impose the existing Extension registration fee.
- (2) Such high school students not covered by specific agreements between their schools and Connecticut State University campuses may enroll in up to two University courses per semester or per summer session for university credit. Such students will be charged regular University Extension course fees and registration fees.
- (3) In cases in which an academic department of a Connecticut State University campus authorizes a specific high school faculty member(s) to teach a University course on a high school campus under the University department's supervision, appropriately qualified high school students



may enroll in up to two such courses per semester for university credit without the payment of University course fees.

(4) All students in the above four categories will be expected to pay regular transcript fees when ordering transcripts.

RESOLUTION

concerning

HIGH SCHOOL-COLLEGE COOPERATIVE PROGRAM at
WESTERN CONNECTICUT STATE COLLEGE

July 15, 1977

WHEREAS, The faculty at Western Connecticut State College has developed a plan to enable qualified high school students to earn college credit while still enrolled in secondary school, and

WHEREAS, Such a program will expand the educational opportunities of high school students, therefore, be it

RESOLVED, That a program to be known as the High School-College Cooperative Program is hereby established at Western Connecticut State College, and, be it

RESOLVED, That high school students enrolled under the High School-College Cooperative Program may earn college credit in courses that are approved by and supervised by the appropriate academic department at Western Connecticut State College and which are authorized by the College President, and, be it

RESOLVED, That a student may earn no more than nine semester hours of college credit in the program and that no college credit shall be considered earned until the student graduates from high school, and, be it

RESOLVED, That, inasmuch as the high schools involved in the High School-College Cooperative Program will bear the cost of instruction, educational supplies, and transportation, the Trustees will make no charge except a two dollar registration fee to be paid by each student, each semester, and deposited in the Educational Extension Fund to be used to cover the costs of record keeping.
