RESOLUTION

WAIVER OF TUITION FEES, STATE UNIVERSITY STUDENT FEE, AND EXTENSION PROGRAM COURSE FEES FOR

PERSONS SIXTY-TWO YEARS OF AGE OR OLDER

July 20, 1990

WHEREAS. Public Act No. 90-147 amended Section 10a-99 of the Connecticut General Statutes and limited tuition waivers for persons

sixty-two years of age or older to Connecticut residents who have

been accepted for admission to an institution of Connecticut State University, provided such person is enrolled in a

degree-granting program or, provided, at the end of the regular registration period, there is space available in the course in

which such person intends to enroll; and

WHEREAS, The Trustees desire to maintain a consistent policy with respect

to the waiver of the State University Student Fee and the

Extension Program Course Fees; therefore be it

That, effective with the 1990 Fall semester, Board Resolutions RESOLVED,

#74-52 and #74-79 are rescinded; and be it

RESOLVED, That, tuition for any qualified Connecticut resident sixty-two

years of age or older, as stipulated above, shall be waived in accordance with the provisions of subsection (d) of section 10a-99 of the Connecticut General Statutes as amended by Public

Act No. 90-147; and be it

RESOLVED, That, as applicable for any qualified Connecticut resident

sixty-two years of age or older as stipulated above, the State

University Student Fee is waived; and be it

RESOLVED, That, Educational Extension Program course fees shall be waived

for any Connecticut resident sixty-two years of age or older who has been accepted for admission to an institution of Connecticut State University, provided such person is enrolled in a degree granting program, provided at the end of the regular registration period there is space available in a course or courses in which

such person intends to enroll; and be it

That the provisions of this resolution shall be effective for the RESOLVED,

1990 Fall Semester.

WAIVER OF STATE COLLEGE FEE AND EDUCATIONAL

EXTENSION PROGRAM COURSE FEES FOR PERSONS

SIXTY-TWO YEARS OF AGE OR OLDER

November 1, 1974

WHEREAS, It was the apparent intent of Public Act 74-282 to provide persons sixty-two years of age or older with educational opportunities at the lowest possible cost; and

WHEREAS, The Trustees enacted Resolution number 74-52, dated July 19, 1974, to carry out the mandate of Public Act 74-282; and

WHEREAS, In furthering the intent of the law, it is the desire of the Trustees to exempt persons sixty-two years of age or older from the payment of the State College Fee and of Educational Extension Program course fees; therefore be it

RESOLVED, That, as applicable, neither the State College Fee nor Educational Extension Program course fees shall be charged to any person sixty-two years of age or older who has been accepted for admission to a State College, provided such person is enrolled in a degree granting program or, if not enrolled in a degree granting program, provided at the end of the regular registration period there is space available in a course or courses in which such person intends to enroll; and be it

RESOLVED, That the effective date of the provisions of this resolution is the first day of the 1974 Fall semester.

WAIVER OF TUITION FEES FOR PERSONS

SIXTY-TWO YEARS OF AGE OR OLDER

July 19, 1974

WHEREAS, Public Act #74-282 mandates that the Board of Trustees for State Colleges waive the payment of tuition fees at the State Colleges:

> ...for any person sixty-two years of age or older, who has been accepted for admission to such institution, provided such person is enrolled in a degree granting program or, provided, at the end of the regular registration period, there is space available in the course in which such person intends to enroll....,

THEREFORE BE IT RESOLVED,

That, the Board of Trustees for the State Colleges authorizes the waiver of tuition for persons sixty-two years of age or older as stipulated above, beginning in the Fall semester of 1974, subject to the approval of the Commission for Higher Education.
