RESOLUTION

concerning

AN INCREASE IN THE STATE UNIVERSITY STUDENT FEE FOR FULL-TIME STUDENTS

December 7, 1990

WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University, subject to the approval of the Board of Governors for Higher Education, shall fix fees for such purposes as the Board of Trustees deems necessary, and

WHEREAS, Revenue produced at current rates is not sufficient to cover the long range facilities program for self-liquidating obligations, be it

RESOLVED, That Board Resolution #89-213 is hereby rescinded, and be it

RESOLVED, That, if the Board of Governors for Higher Education concurs, the State University Student Fee rates be increased from \$145 to \$220 per semester (\$440 per academic year) for residents of Connecticut, and from \$356 to \$541 per semester (\$1,082 per academic year) for nonresidents, to be effective with the Fall semester of 1991.
