- WHEREAS, Revenue produced at current rates is not sufficient to cover escalating costs due to inflation and salary adjustments, be it
- RESOLVED, That Board Resolution #89-212 is rescinded, and be it
- RESOLVED, That, if the Board of Governors for Higher Education concurs, the State University Registration Fee for Extension Students per semester shall be changed as follows, effective for the Fall Semester 1991:
