WHEREAS,	Revenue produced at current rates is not sufficient to cover escalating costs due to inflation and salary adjustments, be it
RESOLVED,	That Board Resolution #89-212 is rescinded, and be it
RESOLVED,	That, if the Board of Governors for Higher Education concurs, the State University Registration Fee for Extension Students per semester shall be changed as follows, effective for the Fall Semester 1991:
