December 7, 1990

WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University, subject to the approval of the Board of Governors for Higher Education, shall fix fees for such purposes as the Board of Trustees deems necessary, and

WHEREAS, The Student Government Association of Central Connecticut State University has recommended an annual increase in the Student Activity Fee from \$49 to \$74 to meet the increase in costs of Student Government organizations and related student activities, be it

RESOLVED, That Board Resolution #89-210 is rescinded, and be it

RESOLVED, That if the Board of Governors for Higher Education concurs, effective for the Fall Semester 1991, the State University Activity Fee be increased as follows:
