SUBJECT: Ernst and Young Additional Furniture Donation

On Monday, March 3, the Records/Registrar's Office was the recipient of a second group of furniture donated to our office by Ernst and Young.

While most items remained in our office area, some items were placed in Public Affairs, the Academic Advisement Center, Institutional Research, University Student Center, Computer Center, and the Academic Vice President's Offices. There are several items still waiting to be moved.

All items were purchased by Ernst and Young over the past ten years, and while no purchase billing statements could be identified, their sense is that most of the furnishings were bought through the following furniture broker:

Corporate Design of Connecticut 26 Fitch Street Norwalk, CT 06855

While the cost of these furnishings is well of \$5,000, there was no way for Ernst and Young to generate an overall dollar value of these goods, since they have been fully depreciated. While not being able to identify the manufacturers of this furniture, I have indicated the University location it has been delivered to for auditing purposes, if necessary.

This additional furniture has certainly created a great deal of excitement in our office, and we all appreciate what the University has done to allow us to receive this donation.
