Projects designed to conserve and restore existing facilities for continued use and to protect the State's capital investment.

Projects to renovate existing facilities to meet new or revised academic programs.

Projects to provide new facilities when existing facilities cannot be feasibly adapted to meet programmed needs, and be it

RESOLVED,

, That the Capital Budget request and priorities for projects for FY 1992-93 are as set forth in Addendum B to this resolution.
