THE GYMNASIUM COMPLEX as the STEPHEN FELDMAN ARENA at WESTERN CONNECTICUT STATE UNIVERSITY

April 3, 1992

- WHEREAS, Dr. Stephen Feldman has provided outstanding leadership to Western Connecticut State University as its President from July 1981 through June 1992, and
- WHEREAS, During this period the quality and reputation of Western Connecticut State University and its students and faculty has been enhanced, and
- WHEREAS, President Feldman was instrumental in making it possible for Western to grow from a college to a university, and
- WHEREAS, President Feldman worked tirelessly and effectively to secure funding for the renovation of the midtown campus, the construction of Ella Grasso Hall, and ultimately for the construction of the William A. O'Neill Athletic and Convocation Center, and
- WHEREAS, The Athletic and Convocation Center shall consist of a natatorium, offices, training facilities and a gymnasium complex which will accommodate 5,000 people and will be utilized for intercollegiate sports, concerts and student athletics, and
- WHEREAS, The Athletic Department faculty members and coaches have recommended that the gymnasium complex be named in honor of Stephen Feldman, therefore, be it
- RESOLVED, That the Board of Trustees for the Connecticut State University congratulates and commends Dr. Stephen Feldman for the contribution that he has made to Western Connecticut State University, and be it further
- RESOLVED, That the gymnasium complex in the Athletic and Convocation Center shall henceforth be known as the Stephen Feldman Arena.
