## FEE INCREASES FOR CONNECTICUT STATE UNIVERSITY STUDENTS TIER II

# May 7, 1993

- WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University shall fix fees for such purposes as the Board of Trustees deems necessary, and
- WHEREAS, The administration at Western Connecticut State University has requested authorization to establish a plan which would permit students to pay tuition and fees over the course of a year, and
- WHEREAS, This plan replaces an outside firm which has provided a similar service for students at a cost of \$45 per participating student although significant administrative support is provided by Western Connecticut State University, and
- WHEREAS, Western Connecticut State University can administer such a plan more cost-effectively, and
- WHEREAS, Western Connecticut State University is requesting a \$50 Payment Plan Fee to cover the costs of personnel, supplies, mail and computer software to administer the plan, therefore be it
- RESOLVED, That Board Resolution 92-127 is amended, and be it further
- RESOLVED, That Western Connecticut State University may establish a Tuition Payment Plan Fee effective for the Fall 1993 semester as reflected in the attached fee schedule.
