

FEE INCREASES FOR CONNECTICUT STATE UNIVERSITY STUDENTS
TIER I

November 5, 1993

- WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University shall fix fees for such purposes as the Board of Trustees deems necessary, and
- WHEREAS, Current plans for the CSU Telecommunications system are that the system will be available in all residence halls effective with the Spring 1994 semester, and
- WHEREAS, To cover the fixed costs of making this service available in the residence halls, each student will be assessed an amount of \$55 a semester, and
- WHEREAS, A portion of the charge will be used to provide a computer hookup to each Residence Hall student which will provide access to the CSU Information System network, library system and Internet, and
- WHEREAS, The former policy which permitted our Universities to raise the extension fee within the approved extension fee ceiling (see BR91-166), and
- WHEREAS, This policy was inadvertently rescinded during the consolidation of fee increase resolutions for FY 1993-94, therefore be it
- RESOLVED, Upon successful installation of the telecommunication system, the housing rate for each Residence Hall student will increase by \$55 per semester effective with the Spring 1994 semester, and be it further
- RESOLVED, That the charges in credit hour fees for the Educational Extension Program for the FY 1993-94 Academic year shall not exceed the maximum set on the attached schedules, and be it further
- RESOLVED, That Resolution BR 93-2 is amended and effective for Spring 1994 the rates shown on the attached schedules shall be charges at each campus as appropriate.
