RESOLUTION

concerning

FEE INCREASES FOR CONNECTICUT STATE UNIVERSITY STUDENTS TIER I

May 5, 1995

- WHEREAS, Section 10a-99 of the general statutes provides that the Board of Trustees for the Connecticut State University system, shall fix fees for such purposes as the Board of Trustees deems necessary, and
 WHEREAS, Central Connecticut State University has been provided a unique marketing opportunity which offers the potential to improve enrollments, increase residence hall occupancy, and enhance operating revenues, and
 WHEREAS, This proposal is consistent with Central's other marketing efforts such as the introduction of new meal plans, guest meals, vegetarian meals, branded concepts (Taco Bell, Pizza Hut), campus debit cards and other such initiatives to improve the campus ambiance, and
- WHEREAS, Central Connecticut State University is requesting support for a plan to enter into an arrangement with TCI Cablevision of Central Connecticut to provide campuswide cable TV access to all students housed in Central's residence halls. Students who currently contract for cable television pay \$235.10 over the school year, or \$19.28 for installation plus \$23.98 per month for nine months, and
- WHEREAS, TCI is proposing to enter into a relationship with Central wherein TCI would charge Central a flat \$94.50 per outlet per year or \$10.50 per outlet per month over the academic year (9 months), and
- WHEREAS, Each student occupying a standard double room would be charged \$40 per semester or \$80 per school year resulting in an annual savings of \$37.55 to each student based upon the current charge, and
- WHEREAS,
 Revenues realized by Central would all go back to students in the form of housing enhancements including television repair services and replacement for those televisions provided by the university, maintenance and replacement of campus television station equipment, and the provision of cable television to Residence Assistants, and
- WHEREAS, This plan which has been unanimously endorsed by the Inter-Residence Council (IRC) and all of the individual residence hall council governing bodies, and

WHEREAS, Central Connecticut State University requested that the Board authorize them to increase the FY1995-96 University General Fee for full-time students residing in university housing, now therefore be it

RESOLVED, That Central Connecticut State University's University General fee for FY1995-96 be increased by an additional \$80.00 per year over the increase approved by the Board in December 1994 to support Central's proposed arrangement with TCI Cablevision of Central Connecticut to provide cable television access to all students residing in Central's residence halls, and be it further

RESOLVED, That the rates reflected on the attached schedule is effective at Central Connecticut State University as appropriate for FY1995-96.
