The following appraisal report has been undertaken to determine the fair market value of the original works of fine art described below. These pieces were donated to the Akus Gallery, Eastern Connecticut State University, Willimantic, Connecticut in December of 1995. This date is the date of value for the purposes of the appraisal report.

It is understood by the appraiser that the owner will attach a statement of cost, date of purchase, the interest transferred to the donee, any fractional interest retained and manner of acquisition in the appraisal summary (IRS Form 8283) to be attached to the owner's tax return. Furthermore, unless otherwise stated, it is assumed that there are no restrictions, understandings or covenants limiting the use or disposition of the works of fine art listed. The appraiser's biographical information and qualifications are appended to the appraisal report.

The basis of the appraisal is the fair market value defined as the price at which these works of fine art would change hands between a willing buyer and a willing seller, neither being under any compulsion to buy or sell and each having reasonable knowledge of the relevant facts, i.e., the price in the marketplace in which the items are most commonly sold to the public at retail as well as the marketplace in which the items are most commonly sold to dealers at wholesale and the marketplace in which the items are most commonly sold to galleries by dealers.

The considerations that were made in the specific determination of the dollar amount of value can be summarized as: artistic merit, supply and demand, relationship to other media, subject matter, style, signature, complexity of technique used, time of execution, standing of the artist, size, vogue and fashion in the marketplace for the artist's work, comparable works by the artist which have been sold in the marketplace, the economic state of the art market for the artist's work, and authenticity. All these relevant factors have been considered in the valuation judgment through the use of the market data approach.
