

EXECUTIVE SUMMARY

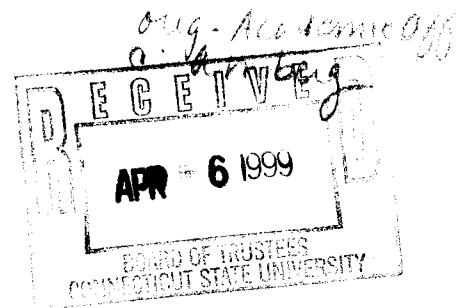
This gift complies with the Board's policy (BR 95-11) which requires that cash gifts of more than \$5,000 be brought to the Trustees for acceptance.
